PROFIT WARNING

This announcement is made by Kwong Man Kee Group Limited (the “**Company**”, and together with its subsidiaries, the “**Group**”) pursuant to Rule 17.10 of the Rules Governing the Listing of Securities on GEM of The Stock Exchange of Hong Kong Limited (the “**GEM Listing Rules**”) and the Inside Information Provisions (as defined under the GEM Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The board (the “**Board**”) of directors (the “**Directors**”) of the Company would like to inform the shareholders of the Company (the “**Shareholders**”) and potential investors that based on a preliminary review of the Group’s unaudited consolidated management accounts for the nine months ended 31 December 2019, the Group is expected to record a substantial decrease in profit by approximately 60% for the nine months ended 31 December 2019 as compared with profit for corresponding period of 2018. Such decline was mainly attributable to (i) the decrease of revenue due to the delay in commencement of some contracts being secured from property developers caused by the market and economic uncertainty since June 2019; and (ii) the increase in impairment loss on trade receivables, staff cost and depreciation during the nine months ended 31 December 2019.

The Company is still in the process of finalising its unaudited consolidated management accounts for the nine months ended 31 December 2019. The information contained in this announcement is only based on the preliminary assessment by the Board on the unaudited consolidated management accounts of the Group for the nine months ended 31 December 2019 and the information available for the time being, which have been neither reviewed by the audit committee of the Company nor audited by the Company’s auditors, and is subject to possible adjustment. Shareholders and potential investors are advised to read carefully the results announcement of the Group for the nine months ended 31 December 2019, which is expected to be released on 10 February 2020.

Shareholders and potential investors are advised to exercise caution when dealing in the shares of the Company.
